## CHILD PROTECTION IN SCHOOL: GUIDANCE FOR PARENTS & CARERS

This information aims to help parents and carers to understand the process of protecting children and the procedures which we, as a school, have to follow.

At Greenfields we see children's welfare as of paramount importance. We are committed to working with parents and carers to ensure that our pupils have a happy, safe and good learning environment both at school and at home.

As a school we are committed to and have a legal duty to safeguard your child's welfare. We follow the model policies and protocols outlined by North Tyneside Safeguarding Children Board (NT SCB) in order to ensure the welfare of our children. All members of staff in school are trained in safeguarding children and are committed to ensuring the safety of all our pupils.

If the school is worried about a pupil's welfare and that a child is at risk of harm, we must legally look into the matter and follow:

- North Tyneside Safeguarding Children Board (NTSCB) child protection procedures
- 'Keeping Children Safe' Guidance from the Department of Education
- The law

# What sort of harm do we mean?

Harm in these circumstances means child abuse or child maltreatment. Somebody may abuse or neglect a child by harming them or not acting to prevent harm. This can include;

- Physical abuse
- Emotional abuse
- Sexual abuse
- Neglect

Enquiries also have to be made if a child is living with someone who has previously been involved in the abuse of another child.

# What will school do?

If a member of staff is concerned that a child is at risk of suffering harm, they will report it to the member of staff responsible for child protection matters called the

Designated Safeguarding Lead. At Greenfields this is the Headteacher, Mrs Robertson; the Deputy Headteacher, Mrs Banks, the Assistant Headteacher, Mrs Cockman and the Lower School Leader, Mrs Wilson are Deputy Designated Safeguarding Leads. Mrs Garnett, who is our Out of Hours Manager is also a Deputy Designated Safeguarding Lead, as she runs holiday clubs when the rest of the school is closed for school holidays.

The Designated Safeguarding Lead will then look into the matter and decide whether it is necessary to contact children's Social Care Services. If the Designated Safeguarding Lead does have concerns about the child's welfare, they must refer this on by law. School contact children's Social Care staff by calling the Front Door Service, which takes the calls relating to these matters.

When a child is referred, school must share all relevant information about the pupil. The Data Protection Act allows school to share personal information with other agencies where there are child protection concerns about a child.

School may let the child's parent(s) or carer(s) know when the child is referred, but cannot contact parents or carers if we think this could put the child at risk. School will seek advice about this from the Front Door Service.

# What happens next?

A social worker, sometimes together with a police officer, will talk to everyone in the family. The social worker will talk to all children who are old enough to find out how they feel and what worries them.

Children and young people have a right to be protected from harm. Families have the right to expect schools to provide a safe and secure environment.

If there are a lot of concerns about a child, a meeting called a 'Child Protection Conference' will be arranged. People who know the child and their family (e.g. a teacher, a doctor or a health visitor) will be invited to this meeting, together with parents or carers, partners and in some cases, older children.

The conference will talk about what has happened and what can be done to help. If necessary a 'Child Protection Plan' will be agreed of all the things people should do to help the child and the family.

Sometimes it may be necessary for a doctor to see the child. If there are other children in the family, they may also need to be seen to make sure that they are ok. Parents or carers will be asked permission before the child is seen by a doctor. Social Care Services will contact parents or carers to let them know what is happening as soon as possible.

# Will my child be taken away from me?

This is often a very real concern for families. In a lot of cases, it is assessed that it is in the best interests of the child to remain at home with their families. This is often where problems are sorted out most effectively. However, the law says that children's Social Care Services must make sure that children are safe. If it is not safe for a child to continue to live at home, the social worker will see if the child can stay with another member of the family. If that is not possible, the social worker will arrange for the child to stay with a foster carer or in a children's residential home unit it is safe for the child to go back home.

# What happens after the investigation?

One of several things may happen after the investigation:

- No further action is needed
- Advice and support is offered (this may be provided by other professionals or agencies)
- A meeting is arranged to decide what will happen next.
